- 1) For value received, the Grantor hereby appoints NTH GEN SOFTWARE INC., OPENLANE CANADA INC., ADESA AUCTIONS CANADA CORPORATION, ADESA MONTREAL CORPORATION, ADESA QUEBEC CORPORATION and ADESA REMARKETING SERVICES INC. (collectively and individually, the "Auction") through its authorized employees and agents to be the Grantor's ATTORNEY in respect of all matters pertaining to the registration, licensing and sale of vehicles owned by or under the legal control of Grantor including, without limitation, to:
  - (i) sign, give, receive and hold, on behalf of the Grantor, all sales agreements, vehicle transfers, vehicle ownerships, titles, odometer disclosure statements and vehicle registrations (in the form used by the Auction or applicable federal, provincial or state regulatory authorities as amended or revised from time to time); and
  - (ii) take all steps, do all things and execute all documents and receipts as the Auction considers necessary, incidental, desirable or expedient in respect of its role as the Grantor's attorney for any Vehicle purchased or sold by the Grantor through the services of the Auction.
- 2) In completing Odometer Disclosure Statements on Grantor's behalf, Auction may rely upon the kilometers or miles (as applicable) displayed on the odometer of any vehicle offered and/or listed for sale by Grantor or on its behalf unless

prior to the sale of the vehicle, Grantor expressly advised the Auction in writing that the vehicle odometer does not display the actual kilometers or miles driven.

- 3) The Auction, buyers and sellers of Vehicles offered for sale through Auction, and federal, provincial and state driver and vehicle licensing offices and transportation authorities are authorized and directed to rely upon this Power of Attorney. This Power of Attorney may be exercised during any subsequent legal incapacity of the Grantor. This Power of Attorney will remain binding on the Grantor until written notice of its revocation is actually received by the Auction.
- 4) In consideration of Auction's agreement to execute such documents on behalf of the Grantor from time to time, the Grantor shall indemnify, defend, and hold harmless Auction, its affiliates, subsidiaries, officers, directors, employees, successors, and assigns (the "**Indemnified Parties**") from and against any and all loss, damages, liability, claims, cause of action, and expenses of whatever kind and nature, arising from the execution by Auction or its employees or agents of any sales agreements, vehicle transfers, vehicle ownerships, titles, odometer disclosure statements and vehicle registrations or other document necessary to transfer ownership of vehicles offered and/or listed for sale by Grantor through the services of Auction. Notwithstanding the foregoing, nothing contained herein shall be construed to require the Grantor to indemnify the Indemnified Parties for losses caused by the wilful misconduct of the Indemnified Parties unless the Indemnified Parties were acting pursuant to the instructions or direction of Grantor or its authorized representatives.
